Subject: **STIP AMENDMENT 10S-031**

## **RECOMMENDATION:**

The California Department of Transportation (Department) recommends the California Transportation Commission (Commission) approve the requested State Transportation Improvement Program (STIP) amendment. The amendment was noticed at the May 2011 Commission meeting.

## **ISSUE:**

The Tehama County Transportation Commission (TCTC) proposes to amend the 2010 STIP to:

- Delete \$2,388,000 of Regional Improvement Program (RIP) for construction in Fiscal Year (FY) 2011-12 from the Red Bluff Transit Facility project (PPNO 2425) in Tehama County.
- Program \$2,388,000 of RIP funding for Plans, Specifications and Estimate (PS&E) and construction in FY 2011-12 for the 99W Overlay project (PPNO 2503) in Tehama County.

## **BACKGROUND:**

The Red Bluff Transit Facility project is currently programmed for construction with \$2,388,000 of RIP funding. The project will now be delivered with Public Transportation Modernization, Improvement, and Service Enhancement Account (PTMISEA) bond funds, resulting in \$2,388,000 of RIP savings.

The 99W Overlay project is a priority for TCTC and is ready to begin once funding has been approved. This project will improve safety and mobility to Route 99W and is essential to goods movement in the region. It is also a continuation of an adjacent project funded from the American Recovery and Reinvestment Act of 2009, which also improves safety and mobility to Route 99W. In addition, this project connects the two regionally significant corridors in Tehama County, I-5 and State Route 99.

## **RESOLUTION:**

Be it Resolved, that the California Transportation Commission does hereby amend the 2010 State Transportation Improvement Program for the Red Bluff Transit Facility project (PPNO 2425) and the 99W Overlay project (PPNO 2503), as described above and reflected in the following tables.
