Subject: **FINANCIAL ALLOCATION AMENDMENT FOR MULTI-FUNDED PROJECT FUNDED WITH STATE HIGHWAY OPERATION AND PROTECTION PROGRAM (SHOPP)/ PROPOSITION 1B TRADE CORRIDOR IMPROVEMENT FUNDS (TCIF) ON THE STATE HIGHWAY SYSTEM**  
**RESOLUTION FP-14-19, AMENDING RESOLUTION FP-13-18**  
**RESOLUTION TCIF-AA-1415-05, AMENDING RESOLUTION TCIF-A-1314-08**

## **RECOMMENDATION:**

The California Department of Transportation (Department) recommends the California Transportation Commission (Commission) amend Resolution FP-13-18 and Resolution TCIF-A-1314-08 to de-allocate \$1,160,000 from TCIF Project 94 (Santa Clara – US 101 Freeway Performance Initiative (PPNO 0499R) a State Highway Operation and Protection Program (SHOPP)/Proposition 1B Trade Corridor Improvement Funds (TCIF) project, in Santa Clara County, thereby reducing the original construction capital allocation from \$15,000,000 to \$13,840,000, to reflect contract award savings.

## **BACKGROUND:**

At its August 2013 meeting, the Commission allocated a total of \$15,000,000 SHOPP/TCIF funds to construction capital. The construction contract was awarded on March 4, 2014, for \$13,840,000. The Department proposes to decrease the SHOPP/TCIF construction capital by \$1,160,000, from \$15,000,000 to \$13,840,000.

The necessary changes are reflected in strikethrough and bold in the vote box below on the attachment.

## **RESOLUTION FP-14-19 and RESOLUTION TCIF-AA-1415-05:**

Be it Resolved, that \$15,000,000 in State Highway Operation and Protection Program (SHOPP)/Proposition 1B Trade Corridor Improvement Funds (TCIF) funds (Budget Act Items 2660-302-0042 and 2660-302-0890) originally allocated under Resolution FP-13-18 and Resolution TCIF-A-1314-08 for TCIF Project 94- Santa Clara – US 101 Freeway Performance Initiative (PPNO 0499R) is hereby amended by \$1,160,000, reducing the original SHOPP/TCIF construction capital allocation to \$13,840,000 in accordance with the vote box below.
