Subject: **STIP AMENDMENT 14S-18**

SUMMARY:

The California Department of Transportation (Department) will request that the California Transportation Commission (Commission) approve the requested State Transportation Improvement Program (STIP) amendment at the next scheduled Commission meeting following the notice period.

ISSUE:

The Department and the Butte County Association of Governments (BCAG), propose to amend the 2014 STIP to revise the implementing agency from BCAG to the Department for the PS&E (Design) and Right-of-Way phases for the State Route 70 Passing Lanes (Segment 1) project (PPNO 9801) in Butte County.

BACKGROUND:

The State Route 70 Passing Lanes (Segment 1) project extends from 0.1 mile south of Palermo Road, to just north of the Ophir Road/Pacific Heights intersection and will widen the roadway from two to four lanes. The Design and Right-of-Way components are programmed in Fiscal Year 2016-17 with BCAG as the lead agency. The Department is currently the lead for the construction phase. It is one of several related projects along the Route 70 corridor that have been constructed in partnership between BCAG and the Department. Based on those recently completed projects, BCAG and the Department have determined that it would be most efficient for the Department to be the lead agency for both the Design and Right-of-Way, along with construction. Cost increases in both Design and Right-of-Way are not anticipated at this time.
