ACTION UPDATE FROM NOTICE

This item was noticed at the July 2000 Commission meeting; the Commission requested the Action Item be placed on the consent calendar as originally proposed.

SUMMARY

This amendment programs \$300,000 from Lassen County's Unprogrammed Balance to reconstruct Spring Ridge Road and improve the connection to Route 139. Total project cost is \$995,000.

RECOMMENDATION

The Lassen County Transportation Commission is requesting this amendment. The Department has reviewed the amendment and found it to be consistent with the Commission adopted STIP guidelines.

BACKGROUND


This amendment programs \$300,000 from Lassen County's Unprogrammed Balance to reconstruct Spring Ridge Road and improve the connection to Route 139. Total project cost is \$995,000.

Lassen County and the Bureau of Indian Affairs are working together to reconstruct Spring Ridge Road to improve the delivery of emergency services, to enhance the quality of school bus transportation for tribal residents attending local schools, and to improve public access to tribal housing developments and community facilities. The Department is contributing \$300,000 of Minor A funding to the project to ensure the safety and operational improvements for this jointly funded public road connection of Spring Ridge Road to Route 139 are made to accommodate the anticipated increase in traffic.
