#### RECOMMENDATION

The Department of Transportation recommends the California Transportation Commission approve the following Resolution.

#### FINANCIAL RESOLUTION

Resolved, that \$13,066,500 be allocated from Items 2660-301-0042 and 2660-301-0890 of the Budget Act of 1999 for the projects on the attached list.

Allocations from 2000-2001 Fiscal Year funds are contingent upon funding being included in the Budget Act of 2000 as adopted by the Legislature and approved by the Governor.

The Department has complied with the National Environmental Policy Act and the California Environmental Quality Act requirements in preparing these projects.

#### SUMMARY AND CONCLUSIONS

This resolution allocates State and Federal funds totaling \$13,066,500 for twenty-nine (29) minor construction projects.
