Subject: **FINANCIAL ALLOCATION ADJUSTMENTS FOR AWARD
RESOLUTION FA-09-16, AMENDING RESOLUTION FP-09-13**

RECOMMENDATION:

The California Department of Transportation (Department) recommends the California Transportation Commission (Commission) approve an adjustment to the allocation amount for the Route 1 Widening Landscaping Project (PPNO 0542H) in Santa Cruz County from \$1,500,000 to \$944,000.

ISSUE:

Section 188.8 of the Streets and Highways Code allows the Commission to adjust an allocation amount, for a capital outlay project in the State Transportation Improvement Program (STIP), if the construction contract award amount for the project is less than 80 percent of the engineer's final estimate. The result would be an adjustment to interregional and/or county shares. The legislation is permissive and it is understood that adjustments to allocations are at the discretion of the Commission.

The Department and Santa Cruz County are requesting a downward adjustment of \$556,000 from \$1,500,000 to \$944,000, for the Route 1 Widening Landscaping Project programmed in the STIP.

BACKGROUND:

On October 15, 2009, the Commission approved Resolution FP-09-13, allocating \$1,500,000 to the Route 1 Widening Landscaping Project to install landscape planting. The project was programmed with Santa Cruz County Regional Improvement Program (RIP) shares for \$1,500,000. The project was awarded on February 11, 2010, and based on the contract award, the current amount needed is \$944,000. The disparity between the engineer's estimate and the low bid is a result of the following:

- Unit prices for plastic pipe ranged from 330 percent to 530 percent lower than the engineer's estimate.
- The bid for plant establishment was \$75,000 (42 percent) lower than the engineer's estimate.
