Dear Ms. Falsetti:

Please accept for your review and approval Amendment #34 to the 2009/12 Metropolitan Transportation Improvement Program (MTIP), as amended by the SACOG Board on May 20, 2010.

Amendment #34 is needed for four primary purposes (see attachments for more detail):

1. Program \$15,035,500 in additional Caltrans highway maintenance and safety work (VAR42000)
2. Program \$3,899,700 in cost savings of earmark funds to begin planning for the I-80/SR65 Interchange Improvement (CAL18797 & PLA25440)
3. Change limits and increase cost by \$8,000,000 for White Rock Road Widening (SAC24470)
4. Program \$7,640,979 net cost increase to the Highway Bridge Program (See VAR56000 & VAR10050)

SACOG amended the MTIP in accordance with its Public Participation Plan. Public comments are included in Attachment #4. Amendment #34 revises grouped project listings (2 revised, 1 deleted) and individually listed projects (2 revised, 1 new). Amendment #34 is accompanied by an air quality conformity determination, as 3 of the projects are non-exempt. Since there were no changes in scope or completion dates across air quality model milestone years, the determination relies on a previous conformity analysis.

SACOG requests your review and approval of the enclosed Amendment #34 followed by transmittal of your findings to FHWA and FTA.

SACOG Response:

The State Highway Bridge Replacement Grouped Projects listing, VAR10050, is developed by Caltrans Headquarters and is not as comprehensible as SACOG's own amendment report, which shows previous and revised versions for easy comparison. In order to improve the readability of this list, SACOG staff will reproduce the list using SACOG's own reporting software. Future amendments that revise this list will be presented in SACOG's own format.

The project has been changed to indicate Sacramento County as the lead.

Comment/Question:

These comments address two bridges in the in the State Highway Bridge Replacement Grouped Projects Detailed Listing, VAR10050:

1. The Roseville Road Bridge replacement, Bridge # 24C0003, shows construction in the "Beyond" category. Pending environmental approval from Caltrans, that project will be ready to go in 11/12 or 12/13. The year 2014/15 is too late
2. The Norwood Ave. Bridge replacement, Bridge # 24C0080, shows \$9M programmed in 12/13 and another \$5.7M programmed in "Beyond". The \$9,078,000 for construction in 2013 is correct, I'm not sure where the other \$5.7M is coming from. The schedule seems incorrect, since

construction will be ready to go in 10/11. We have environmental complete and we have 60% plans done. This should not be a Tier II or III next year because we'll be ready to go.

SACOG Response:

No changes were made. These are projects that Caltrans programmed later, but may choose to advance earlier if circumstances allow.

SACOG alerted Caltrans Headquarters to these two comments because the State Highway Bridge List is managed by Caltrans, not SACOG. Caltrans does not necessarily program state controlled federal Highway Bridge Program (HBP) funds in the year desired by the local agency. Instead, Caltrans programs the funds in the year the funds are available, which may be later than the desired date of the lead agency. If other HBP funded projects with earlier program dates should fail to deliver their project phase, Caltrans may advance other projects from later years to fill that gap.

Comment/Question:

Rio Linda/Magpie bridge rehabilitation project, Bridge # 24C0129 in the State Highway Bridge Replacement Grouped Projects Detailed Listing, VAR10050: This project shows funds programmed in 2008/09. That is an error. The City didn't receive any funding on that project in 8/9. Caltrans has verbally committed to funding it, but has not specified a year.

SACOG Response:

No changes were made. Caltrans programmed the funds for the City to obligate in 2008/09. Programming rules allow the City to still obligate the funds this year (in 2009/10) without changing the programming. At a later date Caltrans will revise this project to program the project in the year it is actually delivered.

WHEREAS, SACOG, as the designated Metropolitan Planning Organization (MPO) for the Sacramento metropolitan planning area as defined by Section 134(c) of the Federal Highway Act, as well as for the Yuba City-Marysville urbanized area; and

WHEREAS, SACOG and the Secretary of Business, Transportation and Housing have executed memoranda of understanding (MOUs) with both the Placer County Transportation Planning Agency (PCTPA) and the El Dorado County Transportation Commission (EDCTC) which establish a framework of representation for how SACOG will carry out its federal MPO responsibilities in both El Dorado and Placer counties in cooperation and coordination with the agencies and jurisdictions in those areas within the ozone nonattainment area; and

WHEREAS, the Federal Clean Air Act Amendments require that “No department, agency, or instrumentality of the Federal Government shall engage in, support in any way or provide financial assistance for, license or permit, or approve an activity which does not conform to an implementation plan after it has been approved or promulgated under Section 110”; and

WHEREAS, “No Metropolitan Planning Organization designated under Title 23 of the U.S. Code, shall give its approval to any project, program or plan which does not conform to an implementation plan approved or promulgated under Section 110”; and

WHEREAS, the SACOG Board of Directors is scheduled to approve Amendment #34 to the 2009/12 MTIP on May 20, 2010; and

WHEREAS, the 2009/12 MTIP through Amendment #34 is fiscally constrained consistent with 23 CFR 450 and 40 CFR 93.108 and includes a financial plan that demonstrates which projects can be implemented using committed funds; and

WHEREAS, the 2009/12 MTIP through Amendment #34 is consistent with the transportation system and financial plan described in the 2035 MTP through Amendment #2; and

WHEREAS, the 2009/12 MTIP through Amendment #34 promotes travel and development patterns that facilitate attainment of established air quality standards contained in the 2009 SIP; and

WHEREAS, the projects contained in Amendment #34 to the 2009/12 MTIP do not interfere with the timely implementation of any transportation control measures (TCMs) in the approved SIP; and

WHEREAS, the assurance of conformity to an implementation plan is the affirmative responsibility of the Executive Director of SACOG; and

WHEREAS, the 2009/12 MTIP through Amendment #34 fulfills interagency and public consultation requirements of 40 CFR 93.105 and 23 CFR 450 and SACOG's Public Participation Plan; and

WHEREAS, the EPA Conformity Rule requires that transportation plans and programs contribute to reductions in reactive organic gases (ROG), nitrogen oxides (NOx) and carbon monoxide (CO) emissions in future years when compared against an emissions budget; and

WHEREAS, the cities and counties within the Sacramento Federal Ozone Nonattainment Area have expeditiously implemented the Transportation Control Measures (TCMs) committed to in the 2009 SIP; and

WHEREAS, no new emissions modeling was required for this conformity determination because the projects were found to conform as part of the previous regional emissions analysis on which a conformity determination was made on January 21, 2010, and is pending approval from the Federal Highway Administration.

NOW, THEREFORE, BE IT RESOLVED, that the SACOG Board of Directors makes the finding that 2009/12 MTIP through Amendment #34, including the Sutter Buttes Ozone Nonattainment Area, conforms with the 2009 SIP and CO Maintenance Plans based upon the Transportation Conformity Requirements for the Sacramento nonattainment areas, as found in the Federal Clean Air Act, Section 176(c) [42 U.S.C. 7506(c)], and Title 40 Code of Federal Regulations, Part 93 Subpart A.

BE IT FURTHER RESOLVED, that SACOG staff is hereby directed and authorized to work with the California Department of Transportation, the Federal Highway Administration, the Federal Transit Administration, and the Environmental Protection Agency to make whatever technical changes or corrections are needed to the content, format and organization of the document to obtain its approval by these agencies.

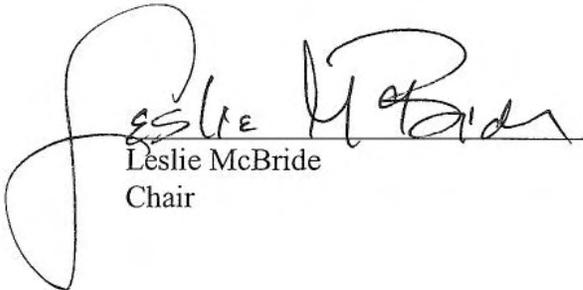
