RE: Administrative Amendment #14 (Type 1) to the Stanislaus Council of
Government's 2009 FTIP

Mr. Aljabiry:

The Stanislaus Council of Governments (StanCOG) Policy Board has authorized its Executive Director to approve Administrative Amendment #14 to StanCOG's 2009 FTIP. The purpose of this letter is to notify Caltrans, FHWA and the FTA that an administrative amendment has been authorized and approved. A summary of changes to projects listed in the 2009 FTIP is attached as well as each project's corresponding CTIPS page. The financial tables have also been revised to reflect funding changes.

Modifications included in this Administrative Amendment meet the criteria identified in the letter issued by FHWA on November 17, 2008, regarding revised Federal/Statewide Transportation Improvement Program Modification Procedures. Per these "Procedures", StanCOG is issuing "minor" changes related to project cost, selection or programming that do not interfere with the timely implementation of any approved TCMs project. None of the project modifications within this amendment require a re-determination of the air quality conformity analysis. Administrative Amendments to the FTIP used in lieu of Formal Amendments are not subject to FHWA approval.

Administrative Amendment #14 modifies funding sources to the StanCOG's SR 132 Expressway and the City of Newman's Downtown Plaza projects.


StanCOG is modifying the SR 132 Expressway project by swapping the existing \$900,000 programmed as TCRP in FFY 08/09 to RIP funds. This swap will also reprogram the funding to FY 09/10.

Caltrans HQ has requested to modify a funding source for the City of Newman's Downtown Plaza Project. The State is substituting existing RIP-TE funds totaling \$516,000 with State ARRA-TE funds. As part of this modification, State officials have granted the City of Newman the authorization to reduce their local match of 11.47% against the \$516,000 and incorporate the difference as State ARRA TE. This modification also requires the programming to change the funds from FFY 08/09 to FFY 09/10. Local funding totaling \$351,385 will also be added to FFY 09/10.

This Administrative Amendment is in accord with Caltrans' Administrative Modification policy as the funding modification does not exceed 25% of total project cost nor \$5,000,000 for a single modification.
