Dear Ms. Kiser and Mr. Sukys:

With this letter, the California Department of Transportation (Caltrans) transmits Administrative Modification No. 13 to the California 2010-2014 Federal Statewide Transportation Improvement Program (FSTIP) which makes minor modification to the Rural non-Metropolitan Planning Organization (MPO) portion of the FSTIP. These changes are consistent with the FSTIP Amendment and Administrative Modification Procedures and have no impact on the rural non-MPO financial constraint or air quality conformity. In addition, there are no projects in this administrative modification that are included in any other amendment that is currently open for public review.

This administrative modification revises the funding of two projects in Calaveras County and modifies the funding for various grouped project listings. Projects included in this modification are funded from Congestion Mitigation and Air Quality Improvement Program, Highway Safety Improvement Program and State Highway Operation and Protection Programs.

Since administrative modifications do not require Federal Highway Administration (FHWA) and/or Federal Transit Administration (FTA) approval, these changes have been incorporated into California's 2011 FSTIP.
