Dear Ms. Kiser and Mr. Sukys:

With this letter, the California Department of Transportation (Caltrans) transmits Administrative Modification No. 21 to the California 2010-2014 Federal Statewide Transportation Improvement Program (FSTIP) which makes minor modification to the Rural non-Metropolitan Planning Organization (MPO) portion of the FSTIP.

This administrative modification modifies funding for three existing projects and grouped project listings. Projects included in this administrative modification are funded from the State Highway Operation and Protection Program and Highway Safety Improvement Program.

These changes are consistent with the FSTIP Amendment and Administrative Modification Procedures and have no impact on the rural non-MPO financial constraint or air quality conformity. In addition, there are no projects in this administrative modification that are included in any other amendment that is currently open for public review.

Since administrative modifications do not require Federal Highway Administration (FHWA) and/or Federal Transit Administration (FTA) approval, these changes have been incorporated into California's 2011 FSTIP.
