The California Department of Transportation has completed the review of the following amendment to the Butte County Association of Governments' (BCAG) 20012/13 - 2015/16 Federal Transportation Improvement Program (FTIP):

No. Description

13 **State, Transit and Local Elements**

- This amendment adds or modifies projects from various funding sources in Butte County. The amendment includes funding from the State Transportation Improvement Program, State Highway Operation and Protection Program, State Bond, Federal Transit Administration (FTA) Sections 5307, 5309(c), and 5339 and local funds.

The BCAG board resolution adopting this FTIP amendment certifies that projects included meet all applicable transportation planning requirements per Title 23 Code of Federal Regulation (CFR) Part 450 and satisfy the applicable air quality conformity requirements.

Projects included in this FTIP amendment, in fiscal years not within the four-year cycle of the current FSTIP, are not approved as part of this FTIP amendment and are shown for information only. Approval of this amendment does not constitute an eligibility determination of project for federal funding.
