The California Department of Transportation (Caltrans) has completed the review of the following amendment to the Metropolitan Transportation Commission's (MTC) 2010/11 – 2013/14 Federal Transportation Improvement Program (FTIP):

It includes projects with funding from the Surface Transportation Program, Congestion Mitigation and Air Quality Improvement Program, Federal Earmarks, State Highway Operation and Protection Program, State Transportation Improvement Program, Highway Bridge Program, Highway Safety Improvement Program, Value Pricing Pilot Program, and various Federal Transit Administration (FTA) programs.

MTC has certified that the amendment is financially constrained, does not change air quality conformity, and meets the requirements of public involvement procedures adopted by MTC.

Pursuant to the authority delegated to me by the Director of Caltrans, I approve MTC's Amendment Number 35. I also recommend that the Federal Highway Administration and FTA approve this FTIP amendment for inclusion into California's 2013 Federal Statewide Transportation Improvement Program (FSTIP). Projects included in this FTIP amendment, in fiscal years not within the four-year cycle of the current FSTIP, are not approved as part of this FTIP amendment and are shown for information only. Approval of this amendment does not constitute an eligibility determination of projects for federal funding.
