The California Department of Transportation has completed the review of the following amendment to the Kings County Association of Governments' (KCAG) 2014/15 - 2017/18 Federal Transportation Improvement Program (FTIP):

- This amendment adds new and modifies existing projects in Kings County funded from the Highway Bridge Program, State Transportation Improvement Program, and Federal Transit Administration (FTA) 5307 Program.

The KCAG board resolution adopting this FTIP amendment certifies that projects included meet all applicable transportation planning requirements per Title 23 Code of Federal Regulation Part 450 and satisfy the applicable air quality conformity requirements.

Approval of this amendment does not constitute an eligibility determination of project for federal funding.
