The California Department of Transportation has completed the review of the following amendment to the Kings County Association of Governments' (KCAG) 2014/15 - 2017/18 Federal Transportation Improvement Program (FTIP):

- This amendment adds new and modifies existing projects in Kings County funded from the Highway Bridge Program, Congestion Mitigation and Air Quality Improvement Program, State Highway Operation and Protection Program, and Highway Maintenance Program.

Approval of this amendment does not constitute an eligibility determination of project for federal funding.
