Dear Mr. de Terra:

The Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) have completed the review of Amendment #22 to the San Joaquin Council of Governments (SJCOG) FY 2015–2018 Federal Transportation Improvement Program (FTIP) that was submitted by your letter dated June 7, 2016. SJCOG adopted Amendment #22 on April 28, 2016. This amendment to SJCOG's FTIP:

- Modifies eight projects and add one new projects in San Joaquin County funded from the State Bond Program, State Highway Operations and Protection Program, Congestion Mitigation and Air Quality Improvement Program, Federal Transit Administration (FTA) 5307 program, and FTA 5339 program


Pursuant to the December 15, 2014, *Memorandum of Understanding between the Federal Highway Administration, California Division, and the Federal Transit Administration, Region IX*, we accept the modifications to the 2015 – 2018 Federal Statewide Transportation Improvement Program (FTIP) for SJCOG region in accordance with the Final Rule on Statewide and Metropolitan Transportation Planning published in the February 17, 2007 Federal Register. We find that the SJCOG's FTIP, through Amendment # 22, was developed through a continuing, cooperative and comprehensive transportation planning process carried out in accordance with the metropolitan planning provisions of 23 U.S.C. 134, and 49 U.S.C. Chapter 53 as amended by Public Law 114-94, the "*Fixing America's Surface Transportation Act*" (FAST Act).

We have determined that this program modification is exempt from the regional emissions analysis requirements pursuant to the transportation conformity provisions found in 40 CFR Part

93. This finding has been coordinated with Region 9 of the Environmental Protection Agency (EPA) in accordance with the procedures outlined in the *National Memorandum of Understanding between DOT and EPA on Transportation Conformity*, dated April 25, 2000. Therefore, we find that the FTIP continues to conform to the applicable State Implementation Plan (SIP).
