The California Department of Transportation has completed the review of the following amendment to the San Joaquin Council of Governments' (SJCOG) 2014/15 - 2017/18 Federal Transportation Improvement Program (FTIP):

7	Local and Transit Elements

- This amendment adds new and modifies existing projects in the San Joaquin County funded from the Highway Bridge Program, Congestion Mitigation and Air Quality Improvement Program, Federal Transit Administration (FTA) 5310 program, and local funds.

The SJCOG board resolution adopting this FTIP amendment certifies that projects included meet all applicable transportation planning requirements per Title 23 Code of Federal Regulation Part 450 and satisfy the applicable air quality conformity requirements.

Pursuant to the authority delegated to me by the Director of Caltrans, I approve SJCOG's Amendment Number 7. I also recommend that Federal Highway Administration (FHWA) and the FTA approve this FTIP amendment for inclusion into California's 2015 Federal Statewide Transportation Improvement Program (FSTIP). Projects included in this FTIP amendment, in fiscal years not within the four-year cycle of the current FSTIP, are not approved as part of this FTIP amendment and are shown for information only. Approval of this amendment does not constitute an eligibility determination of project for federal funding.


