

Caltrans Quality Assurance (QA) Inspector was present to witness procedure qualification (PQR) HP200749 as requested by ZPMC. The test plate was welded in the 1F (flat) position, using the submerged arc welding (SAW) automatic welding process. The welding consumable electrode is identified as 4.8mm diameter, specification AWS A5.17, classification EH14 and S-777MXH flux. The welding was performed in accordance with AWS D1.5 and appeared to comply with the contract documents. Caltrans QA Inspector assigned lot number B49-015-07.
