This QA Inspector observed the following work in progress:

SMAW in the 3G position for the OBG Segment 7AW to 7BW, weld No.SP429-001-035. The welder is identified as #069683. ZPMC QC is identified as Mr.Li Yang. The welding variables recorded by QC appear to comply with WPS-B-P-2213-B-U2.

SMAW in the 3G position for the OBG Segment 7AW to 7BW, weld No.SP124-001-038. The welder is identified as #068917. ZPMC QC is identified as Mr.Li Yang. The welding variables recorded by QC appear to comply with WPS-B-P-2213-B-U2.

SMAW in the 3G position for the OBG Segment 7AW to 7BW, weld No.SP151-001-042. The welder is identified as #068917. ZPMC QC is identified as Mr.Li Yang. The welding variables recorded by QC appear to comply with WPS-B-P-2213-B-U2.

The QA Inspector observed that the ZPMC personnel is performing Carbon Arc Gouging from outside after welding from inside at side plate to side plate splice joint joining between 7AW to 7BW at Counter Weight Side.

The weld joint is identified as OBW7B-004.

After Blast Inspection

This Quality Assurance (QA) Inspector performed random visual inspection of OBG segment 8CE internal side panel, bottom panel, floor beam and longitudinal diaphragms surfaces from the panel point 68 to 69 after grit blasting. Areas that marked for repair were recorded for future repair. Areas requiring additional grinding were marked by QA and repaired by ZPMC personnel.

Unless otherwise noted, all work observed on this date appeared to generally comply with applicable contract documents.
