This QA Inspector randomly observed the following work in progress on the heavy dock:

ZPMC workers performed at the lift 1/ lift 2 joints of either of the towers.

North tower, lift 2 was suspended from the ZPMC 1600 ton floating crane while in position on top of north tower, lift 1. ZPMC workers were manually installing and removing bolts at the splice plates of skins A and E through exterior splice plates.

Unless otherwise noted, all work observed on this date appeared to generally comply with applicable contract documents.
