Welding was performed according to the weld repair report B-WR21173. The welding variables recorded by QC appeared to comply with the WPS-345-SMAW-3G(3F)-FCM-Repair.

This QA Inspector observed the following work in progress:




This QA Inspector observed the following work in progress:

SMAW in the 4G position for the OBG Segment 14W Floor Beam Stiffener. The weld joint was designated as: SEG3020AW-100. The welder is identified as #066261. ZPMC QC is identified as Mr. Zhu Lin. The welding variables recorded by QC appear to comply with WPS-B-P-2214-TC-U4B-FCM-1.

This QA inspector observed ZPMC personnel's performed Magnetic Particle Testing on Bottom panel "I" ribs connection plate of OBG Segment 14E. Please see the attached picture.
