QA Inspector signed green tag paperwork (with "per ABF documentation" note) that ABF QC Zhang Hui Long presented to QA Inspector. Approximately 25 ZPMC workers were present performing FCAW-G on various tower diaphragm flanges. No apparent indications were observed. Items observed appeared to comply with project specifications.
