On this date CALTRANS OSM Quality Assurance (QA) Inspector Rory O'Kane was present during the times noted above for observations relative to the work being performed.

OBG Assembly Bays 2, 3 &amp; 19

This QA Inspector observed ZPMC welding personnel performing Flux Core Arc Welding (FCAW) of Complete Joint Penetration (CJP) welds on OBG floor beam assemblies designated as 1AW, 1AE, 1AAW & 1AAE. In process FCAW appears to be progressing in compliance with Caltrans Engineer Approved welding procedure.

This QA Inspector performed visual inspection on Bottom Plate # BP026-002-002 to confirm plate alignment tolerances. Weld noted as being rejectable due to plate misalignment of 5mm.

This QA Inspector reviewed the contract files and tracking logs for the Magnetic Particle Testing (MT), Ultrasonic Testing (UT), Welding Procedure Specifications (WPS), Procedure Qualification Records (PQR), and QC Inspector records to this date.

Unless otherwise noted, all work observed on this date appeared to be in general compliance with the applicable contract documents.

Only general conversation was held between QA and QC concerning this project.
