On this day CALTRANS OSM Quality Assurance Inspector (QA) Shrikant Utekar was present during the times noted above for observations relative to the fabrication of the SAS Superstructure being performed by Zhenhua Port Machinery Company (ZPMC) at Changxing Island in Shanghai, China. QA observed and/or found the following:

HEAVY DOCK/ JETTY

ULTRASONIC INSPECTION

OBG SEGMENT 3AW-3BW

This Quality Assurance (QA) Inspector performed conventional UT (Ultrasonic Testing) along with Caltrans Quality Assurance (QA) Inspector Mr. Dawson after ABF Ultrasonic inspection for detection of planar transverse indication.

UT performed on side panel splice weld between OBG segment 3AW and 3BW (OBW3A-002) utilizing scanning pattern A, B, C and D (Fig 6.7). During the inspection this Quality Assurance (QA) Inspector found one transverse indication that had not identified by ABF. The Y location of indication was measured approximately 1200mm.
