ZPMC CWI Identified as Mr. Zhao Chen Sun. The welding parameters as measured using QC's calibrated instruments appeared to be in general compliance with WPS-B-T-2333-TC-P4-F.

### Magnetic Particle Testing:

This QA inspector performed Magnetic Particle Testing (MT) of approximately 15% of the area previously tested and accepted by ZPMC Quality Control personnel. This QA Inspector generated a TL-6028 MT report for this date. The member is identified as East and West tower Bearing stiffener at Heavy dock jetty. The weld designations reviewed are as follows:

ESD1-FA233, Jt. nos. – 25, 28 – Skin B-East tower

WSD1-SA279, Jt. nos. – 33, 30, 27, 24, 21, 18 – Skin B –West tower

Unless otherwise noted, all work observed on this date appeared to generally comply with applicable contract documents.
