
The Quality Assurance Inspector (QAI), Scott Croff, was present at the Self Anchored Span (SAS) job site to observe the scheduled fabrication and welding of components for the SFOBB project.

The QAI reviewed contract related documents including the Welding Quality Control Plan (WQCP), revisions to the WQCP, requests for weld repairs and QA tracking information. The QAI updated the records of the non-conforming incident reports.

The QAI made observations of the 2nd shipment of orthotropic box girder (OBG) components including segment 5E, 6E, 6W and their associated cross beams. The QAI noted that the components have been loaded onto barges for job site storage. The QAI observed ABF personnel in the process of removing the type C and type G temporary shoring from the OBG segments. The QAI also noted that ABG personnel are staging equipment and parts in the OBG segments in preparation for the eventual erection and field splice welding. See the attached photos. The QAI noted that the post arrival inspections have not been performed at this time. The QAI Lead Bill Levell informed the QAI that the post arrival inspection will begin on segment 5E tomorrow, 4-27-2010. The QAI reviewed the punch list and associated shipping information that will be checked during the inspection.
