ZPMC was observed on this date performing grinding on various welds for PCMK W5-SB2-015, W5-SB1-046, W5-SB10-017, W5-SB26-001, W5-SB21-001, W5-SB1-106, W5-SB20-002, and W5-SB1-108. It was noted that during the grinding operation ZPMC was both cleaning the welds and grinding the welds to the appropriate contour.

ZPMC was observed on this date performing match drilling on PCMK W5-SB2-9A-003.

ZPMC was observed on this date performing layout of fit-up for PCMK W2-SB8-003.
